### Climate Change Council

#### Background

Sub-section 10(1) of the *Remuneration Tribunal Act 1995* provides for the ACT Remuneration Tribunal (the Tribunal) to inquire into, and determine the remuneration, allowances and other entitlements of the holders of any position or appointment notified in writing to the Tribunal by the Chief Minister.

The Chief Minister has referred the Chair and Members of the ACT Climate Change Council to the Tribunal for such determination.

#### Tribunal Consideration

The Climate Change Council is a new statutory body established under the *Climate Change and Greenhouse Gas Reduction Act 2010*.

The Tribunal considered that the Council is an advisory body with a similar level of responsibility as other entities that have advisory responsibilities. The Tribunal determined remuneration of \$430 per diem for the Chair and \$365 per diem for Members with effect from 24 January 2011, the date of referral.

#### The Tribunal determines as follows:

Pursuant to section 10(1) of the *Remuneration Tribunal Act 1995* the Remuneration Tribunal has inquired into the remuneration and allowances to be paid, and other entitlements to be granted to the person holding the part-time public offices of Chair or Member of the Climate Change Council, and determines as follows: -

1. That Attachment 1 of Determination Number 12 of 2010 made in December 2010 be varied by inserting the following: -
